- Dancers will dance in inverse order of entry
- Current SCOTDANCE (2019) card must be provided to the organizer on the day of competition.
- Dancers must remain in costume to receive awards
- Judges decision is FINAL. No persons other than the competition organizers will communicate with the judge.
- Protests must be made in writing, signed and submitted to the competition organizer before the end of the competition with a \$15.00 fee. The fee will be refunded if the protest is sustained.
- THREE MONTH RULE-Any dancer having attended a workshop or classes of any kind with the judge within three months prior to the competition is not eligible to compete. This is the responsibility of the dancer.
- **CLOSING DATE – Postmarked no later than 10/10/19. No Exceptions**
